JOINT PROPOSED SCHEDULING ORDER

A. Case Management Track.

Due to the complex nature of the above styled case and upon the joint position of counsel that additional time for discovery is needed due to the number of potential deponents, the complexity of certain issues, and the potential for depositions in foreign countries, this matter is assigned to the Complex case management track pursuant to Local Rule 16.1(a)(2)(C).

B. Discovery Schedule Agreed to by the Parties.

The parties shall comply with the deadlines set forth below:

C. Referral to Magistrate Judge.

Pursuant to 28 U.S.C. § 636 and this District's Magistrate Judge Rules, all discovery motions are referred to the Magistrate Judge.

D. Need for Rule Variations.

The parties have agreed to extend the maximum deposition duration, imposed by Fed. R.

Civ. P. 30(d)(1), from seven (7) hours to twelve (12) hours without leave of the Court for all

witnesses who require an interpreter.

Furthermore, the parties have agreed that it may be necessary to exceed the maximum

limitation on the number of depositions which may be taken without leave of the Court pursuant

to Fed. R. Civ. P. 30(a)(2)(A). Accordingly, the parties have agreed that each party may take up

to thirteen (13) oral/videographic depositions of fact witnesses without leave of Court.
